

AMENDMENT #7

This is an Amendment to the Contract ("Contract") previously entered into by and between the Office of the Indiana Attorney General ("State") and SCHAERR JAFFE LLP ("Contractor") approved by the last State signatory on March 30, 2020, with Amendment #1 approved on April 22, 2021, Amendment #2 approved on May 11, 2022, Amendment #3 approved on August 11, 2022, Amendment #4 approved on December 19, 2022, Amendment #5 approved on July 6, 2023, and Amendment #6 approved on September 1, 2023.

In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree as follows:

1. The Contract term is unchanged by this Amendment #7. It shall terminate on December 31, 2024.
2. The consideration added by to this Amendment #7 is \$400,000.00. Total remuneration under the Contract is not to exceed \$1,500,000.00.

All matters set forth in the original Contract and not affected by this Amendment shall remain in full force and effect.

Non-Collusion and Acceptance

The undersigned attests, subject to the penalties for perjury, that the undersigned is the Contractor, or that the undersigned is the properly authorized representative, agent, member or officer of the Contractor. Further, to the undersigned's knowledge, neither the undersigned nor any other member, employee, representative, agent or officer of the Contractor, directly or indirectly, has entered into or been offered any sum of money or other consideration for the execution of this Amendment other than that which appears upon the face hereof. **Furthermore, if the undersigned has knowledge that a state officer, employee, or special state appointee, as those terms are defined in IC § 4-2-6-1, has a financial interest in the Contract, the Contractor attests to compliance with the disclosure requirements in IC § 4-2-6-10.5.**

Agreement to Use Electronic Signatures

I agree, and it is my intent, to sign this Contract by accessing State of Indiana Supplier Portal using the secure password assigned to me and by electronically submitting this Contract to the State of Indiana.
