## **AMENDMENT #1**

This is an Amendment to the Contract (the "Contract") entered into by and between the Indiana Gaming Commission (the "State") and SPECTRUM GAMING GROUP FL LLC (the "Contractor") approved by the last State signatory on February 8, 2022.

In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree as follows:

- 1. The Contract is hereby extended for an additional period of two (2) years. It shall terminate on January 28, 2026.
- 2. The consideration during this extension period is \$62,750. Total remuneration under the Contract is not to exceed \$137,500.
- 3. All references to utilizing Dant Advocacy, Inc. and Niche Agency are removed from Paragraph 32 of the Contract.

All matters set forth in the original Contract and not affected by this Amendment shall remain in full force and effect.

## Non-Collusion and Acceptance

The undersigned attests, subject to the penalties for perjury, that the undersigned is the Contractor, or that the undersigned is the properly authorized representative, agent, member or officer of the Contractor. Further, to the undersigned's knowledge, neither the undersigned nor any other member, employee, representative, agent or officer of the Contractor, directly or indirectly, has entered into or been offered any sum of money or other consideration for the execution of this Contract other than that which appears upon the face hereof. Furthermore, if the undersigned has knowledge that a state officer, employee, or special state appointee, as those terms are defined in IC § 4-2-6-1, has a financial interest in the Contract, the Contractor attests to compliance with the disclosure requirements in IC § 4-2-6-10.5.
